	<p>The use in children and adolescents under 18 years of age has not been established due to lack of adequate data.</p> <p>Due to possible stimulation on bile secretion <i>Curcuma longa</i> is not recommended in case of obstruction of the bile duct, cholangitis, liver disease, gallstones and any other biliary diseases.</p> <p>If the symptoms worsen during the use of the medicinal product, a doctor or a qualified health care practitioner should be consulted.</p> <p>For tinctures containing ethanol, the appropriate labelling for ethanol, taken from the 'Guideline on excipients in the label and package leaflet of medicinal products for human use', must be included.</p>
